



# DISCLOSURE REGARDING PROGRAM PREPARATION FOR PROFESSIONAL LICENSURE OR CERTIFICATION

The University of Central Florida is committed to providing clear and accurate information to current and prospective students to help inform career planning. The UCF program identified above prepares students to practice in a field with professional licensure or certification available. However, specific licensure and certification requirements can and often do vary by state<sup>1</sup>. Requirements typically include earning a degree or other educational credential in the field from an institution and program that meet certain eligibility requirements in that state (e.g., curricular requirements, accredited status, approval by the state licensing board); passing a state or national exam; working in the field for a minimum period of time; and/or completing a certain number of clinical hours. If your career plans include pursuing professional licensure or certification in your chosen field, it is important to become educated on the credentialing requirements of the state in which you hope to practice.

## UCF Program Preparation in the State of Florida

The above-named UCF graduate certificate meets some of the educational course requirements for educator certification in the State of Florida. Individuals with a bachelor's or higher degree in a content area, who are currently teaching in a Florida public school, and who successfully complete the ITPP graduate certificate program are eligible to apply for Florida temporary educator certification while completing any other state certification requirements. ## UCF Program Preparation in Other US States

As a member of the National Council for State Authorization Reciprocity Agreements (NC-SARA), UCF is authorized to offer educational programs in all states (except California), the District of Columbia, Puerto Rico, and the US Virgin Islands. The state of California is not currently a member of NC-SARA, but UCF is authorized to offer educational programming there as well.

Because state Department of Education certification requirements differ and change, we are unable to determine whether or not the above-named graduate certificate meets the educational requirements for

If you have an interest in pursuing licensure or certification outside the state of Florida, you are strongly advised to determine whether or not this graduate certificate specifically meets the educational requirements for graduates to be eligible to apply in that location.
