

# DISCLOSURE REGARDING PROGRAM PREPARATION FOR PROFESSIONAL LICENSURE OR CERTIFICATION

PROGRAM

Nursing, BSN

The University of Central Florida is committed to providing clear and accurate information to current and prospective students to help inform career planning. The UCF program identified above prepares students for state-regulated professional licensure or certification. However, specific licensure and certification requirements may vary by state or territory. Requirements typically include earning a degree or other educational credential from an institution and program that meet certain requirements in that state (e.g., specific coursework, accredited status); passing a state or national exam; and/or working in the field for a period of time or completing a certain number of clinical hours. If your career plans include pursuing professional licensure or certification, it is important to become educated on the credentialing requirements of the state in which you intend to practice.

Effective July 1, 2024, federal regulation requires the university to meet all educational requirements for state-regulated licensure or certification in every US state and territory where its eligible programs are offered. This disclosure is intended to provide you with information regarding the educational preparation you will receive in your chosen program of study<sup>i</sup>.

### UCF Program Preparation in the State of Florida

The Nursing (BSN) program is designed for in-person course delivery. Although some limited online options may be available, students must take a preponderance of their coursework in the major in-person within the State of Florida.

This program meets the educational requirements for licensure as a Registered Nurse (RN) in the State of Florida. Students who graduate from this program at UCF will meet the educational eligibility criteria for the National Council for Licensure Examination for Registered Nurses (NCLEX-RN) for obtaining their license to practice as a registered nurse in Florida. UCF's Registrar's Office will first verify and confirm all degree requirements have been satisfied. UCF College of Nursing will then provide a list of NCLEX-RN BSN degree candidates to Florida's State Board of Nursing. We recommend that students take the NCLEX-RN within 4-8 weeks of graduation.

### UCF Program Preparation in Other US States and Territories<sup>iii</sup>

As a participant in the State Authorization Reciprocity Agreements (SARA), UCF is authorized to offer educational programs in all states (except California), the District of Columbia, Puerto Rico, and the US Virgin Islands. The State of California is not currently a member of SARA, but UCF is separately authorized to offer educational programming there as well.

We are currently unable to determine whether or not the Nursing (BSN) program meets the educational requirements for graduates to be eligible to apply for licensure or certification in any additional states.

### Enrollment Eligibility Restrictions<sup>iv</sup>

To comply with federal enrollment restrictions, UCF may only enroll students physically located in the states and territories where it meets all educational requirements for the credential it prepares students to achieve. Accordingly, we are generally unable to enroll students physically located in other states and territories during their first term of enrollment in the major unless they intend to pursue licensure in a state or territory where UCF does meet educational eligibility requirements and submit a written attestation to this effect. Otherwise, students physically located in an ineligible state during their first term of enrollment must select a major that is free from out-of-state enrollment restrictions. Please reach out to the program contact listed below for additional guidance in this regard.

This program is primarily a face-to-face program taught in Florida. If online courses are allowed during this degree program, you may enroll in these online courses **as long as you will be physically located in a NLC state for the duration of your education**.

UCF College of Nursing faculty are authorized to teach in NLC states. Due to nursing education restrictions imposed by non-NLC states, UCF is unable to offer courses, clinicals, or other educational services regardless of modality within non-NLC states. Should you be physically located within a non-NLC state for more than a vacation or brief visit, regardless of your legal state of residence or the type of license you have, you will be unable to apply or continue your nursing degree program at the UCF College of Nursing. This includes, but is not limited to, students accepting traveling nurse positions in a non-NLC state. Although Colorado is a NLC state, the UCF College of Nursing cannot enroll students who will complete clinical practice hours there due to Colorado statute requirements for worker's compensation insurance coverage.

### **Programmatic Accreditation**<sup>v</sup>

UCF's Bachelor of Science in Nursing (BSN) programs are nationally accredited by the Commission of Collegiate Nursing Education (CCNE). Programmatic accreditation is typically required for state-regulated licensure in this field. Recognition by CCNE is specific to the program and is distinct from <u>UCF's</u> <u>institutional accreditation</u> that is required for other purposes, including UCF's authorization to award federal financial aid to students.

### **Nurse Licensure Compact (NLC) Information**

As Florida is part of the Nurse Licensure Compact (NLC), nurses with a RN license in the state of Florida may be eligible to apply for a compact license to practice in the other NLC states, districts and US territories. This list is continually updating pending legislative changes. ## UCF Program Eligibility Outside the United States

This disclosure does not address program eligibility in countries outside the United States. We are unable to determine whether or not the Nursing (BSN) degree program meets the educational requirements for graduates to be eligible to apply for licensure or certification outside the United States.
