The University of Central Florida is committed to providing clear and accurate information to current and prospective students to help inform career planning. The UCF program identified above prepares students for state-regulated professional certification or endorsement. However, specific certification or endorsement requirements may vary by state or territory. Requirements typically include earning a degree or other educational credential from an institution and program that meet certain requirements in that state (e.g., specific coursework, accredited status); passing a state or national exam; and/or working in the field for a period of time or completing a certain number of clinical hours. If your career plans include pursuing professional certification or endorsement, it is important to become educated on the credentialing requirements of the state in which you intend to practice.

Effective July 1, 2024, federal regulation requires the university to meet all educational requirements for state-regulated licensure or certification in every US state and territory where its eligible programs are offered. This disclosure is intended to provide you with information regarding the educational preparation you will receive in your chosen program of studyⁱ.

UCF Program Preparation in the State of Florida

The Teacher Education (MAT) program meet the educational requirements for certification in the State of Florida as described below:

- Art Education Track – certification in Art (Grades K-12)
- English Language Arts Education with ESOL Endorsement Track – certification in English (Grades 6-12)
- Mathematics Education Track – certification in Mathematics (Grades 6-12)
- Middle School Mathematics Education Track – certification in Middle Grades Mathematics (Grades 5-9)
- Middle School Science Education Track – certification in Middle Grades General Sciences (Grades 5-9)
- Science Education, Biology Track – certification in Biology (Grades 6-12)
- Science Education, Chemistry Track – certification in Chemistry (Grades 6-12)
- Science Education, Physics Track – certification in Physics (Grades 6-12)
- Social Science Education Track – certification in Social Science (Grades 6-12)
- World Languages Education Track - certification in World Languages (Grades K-12)

Graduates of these Florida state-approved teacher preparation programs who have passed all applicable Florida Teacher Certification Examinations (FTCE) will qualify for a Professional Florida Educator's Certificate. UCF Program Preparation in Other US States and Territoriesⁱⁱⁱ

As a participant in the State Authorization Reciprocity Agreements (SARA), UCF is authorized to offer educational programs in all states (except California), the District of Columbia, Puerto Rico, and the US Virgin Islands. The State of California is not currently a member of SARA, but UCF is separately authorized to offer educational programming there as well.

We are currently unable to determine whether or not the Teacher Education (MAT) program meets the educational requirements for graduates to be eligible to apply for certification or endorsement in any additional states.

If you are interested in seeking certification or endorsement outside of the State of Florida, we encourage you to review the appropriate state board of education information to determine all requirements needed to obtain your credential of interest. Enrollment Eligibility Restrictions^{iv}

To comply with federal enrollment restrictions, UCF may only enroll students physically located in the states and territories where it meets all educational requirements for the credential it prepares students to achieve. Accordingly, we are generally unable to enroll students physically located in other states and territories during their first term of enrollment in the program unless they intend to pursue licensure in a state or territory where UCF does meet educational eligibility requirements and submit a written attestation to this effect. UCF Program Preparation Outside the United States

This disclosure does not address program eligibility in countries outside the United States. We are unable to determine whether or not the Teacher Education (MAT) program meets the educational requirements for graduates to be eligible to apply for certification or endorsement outside the United States.
